

System introduction

Thank you for choosing the Rose Electronics® CrystalLink™ USB Fiber extender. The CrystalLink USB Fiber Extender is the result of Rose Electronics commitment to providing state-of-the-art solutions for today's demanding workplace. The CrystalLink USB Fiber has proven to be a valuable investment for any business, big or small, that has a need to access their USB 1.1 or 2.0 peripherals from a remote location. This location can be up to 6 miles away using singlemode fiber cable (1,650 feet using multimode fiber cable).

The receiver unit provides 4 USB ports for connecting your USB peripherals. The number of peripherals can be increased by using a standard USB hub.

The USB peripherals can be USB 1.1 devices (low-speed or full-speed) or USB 2.0 high-speed devices operating up to 480 Mb/s. The receiver unit can supply up to 500 ma per USB port for driving high-power USB devices.

Plug-and-play installation makes installing the transmitter and receiver simple and easy. Connect the transmitter to the computers USB port, connect the 4 USB ports on the receiver to your USB devices, connect the transmitter to the receiver with up to 6 miles of singlemode fiber cable, connect the power adapters to the transmitter and receiver and power on the system. The USB devices will function normally as if they are directly connected to your computers USB port even though they are up to 6 miles away.

Features

- Supports USB 1.1 (low and full speed) and USB 2.0 (high-speed)
- Extends USB devices up to 33,000 feet (10Km) over singlemode fiber, 1,650 feet (500m) over multimode fiber cable
- 4-USB ports on the receiver unit
- Up to 500 ma of power is available at each USB port for powering high-power USB devices
- Standard USB hubs can be used to increase the number of connected USB devices.
- Plug-and-Play installation , no configuration or set-up needed
- Operating system independent, supports all major operating systems

Package contents

The package contents consist of the following:

- The CrystalLink USB Fiber transmitter and receiver units
- One (1) 6 foot USB type A to type B cable
- Two (2) power adapter for the transmitter and remote units. (Auto-switching transformer)
- Installation and operations manual.

Fiber and USB cables are usually ordered separately. If the package contents are not correct, contact Rose Electronics or your reseller, so the problem can be quickly resolved.

INSTALLATION


Please refer to the safety section first before proceeding with any installation of the CrystalLink USB Fiber extender.

Installation of the CrystalLink USB Fiber extender consists of following procedures:

1. Connect a USB cable from the transmitter to a computer's USB port using a USB type A to type B cable.
2. Connect the USB peripherals to the receiver.
3. Connect the transmitter to the receiver with up to 33,000 feet of industry standard singlemode fiber cable with fiber duplex LC connectors (1,650 feet using multimode fiber cable)
NOTE: Fiber cable must provide a duplex connection with crossover and terminated with Duplex LC connectors at both ends
4. Connect the power adapters to the transmitter and receiver and applying power.
5. Verify the power LEDs on the transmitter and receiver are on
6. Verify the Link LEDs on the transmitter and receiver are on
7. Verify the Host LED on the transmitter is on
8. Open the Device Manager on the host computers control panel and click on the + next to the Universal Serial Bus controllers. If the CrystalLink USB Fiber extender has been installed correctly, it will be listed as a Generic USB Hub.

NOTE: The host computer must be equipped with an EHCI (USB 2.0) host controller. OHCI/UHCI (USB 1.1) host controllers are not supported.

For Premise cabling, the total fiber cable length, including patch cords must not exceed the maximum cable length specifications for multimode and singlemode fiber cables.



Operating Instructions

Operating your CrystalLink USB extender is no different than having your USB peripherals directly connected to your computer's USB port.

Any compatible USB device can be totally controlled and operated normally with no special configuration or commands. USB printers, digital cameras, scanners, or any compatible USB 1.1 or 2.0 device will function properly. If more than 4 USB devices need to be remotely accessed, you can add a standard USB hub to increase the number of USB devices.

When using a USB hub, keep in mind that each USB port on the receiver can supply up to 500ma of current. Connecting a 4-port USB hub to one of the CrystalLink USB receiver ports supplies a max current to the hub of 500ma or 125ma per hub port.

Troubleshooting Guide

The troubleshooting section is used as a guide to understanding the capabilities of the CrystalLink USB Fiber extender and for general troubleshooting. If you have any problems or questions concerning the installation, operation or usage of the CrystalLink USB Fiber extender that is not covered in this manual, please contact Rose Electronics for technical support.

All LEDs on the transmitter or receiver are off

- Verify that the power adapter is connected to the unit and to a live power source

Link LEDs on the transmitter and receiver are both off

- Verify the fiber cable (with crossover) is securely connected to the transmitter and receiver duplex LC connectors

Host LED on the transmitter is off

- Verify the USB cable from the transmitter to the computer's USB port
- Verify that the computer supports USB hubs
- Verify that the CrystalLink USB Fiber is recognized in the device manager as a Generic USB Hub, if not, contact tech support

All LEDs are on but the USB device does not operate correctly

- Connect the USB device directly to the computer's USB port. If the device functions properly, connect a different type of USB device to the receiver port the non-operating USB device was connected to. If this device does not function, the unit may be malfunctioning, contact tech support. If the device operates properly, the first USB device may not be compatible with the CrystalLink USB Fiber extender. Contact tech support for assistance.
